The Republic of the Marshall Islands Ports Authority (RMIPA), a public corporation of the Republic of the Marshall Islands, is hereby soliciting Statements of Professional Qualifications from interested design-build firms for the purpose of designing and constructing approximately 8700ft (with additional 500ft as an add alternate) of perimeter security fence along the south side of the Amata Kabua (Majuro) International Airport (AKIA), Majuro Atoll, Marshall Islands. This work will be performed and constructed under the Federal Aviation Administration (FAA) Airport Improvement Program (AIP) grant to RMIPA.

The design-build project is comprised of the following main objectives:

- In accordance with FAA AC Circular 107-1 create design drawings for the Runway Safety Area (RSA) Security Fencing System along the south side of RWY7
- Provide wind load calculations on the purpose fence installation
- Acquire all materials from Betafence USA for installation at AKIA
- Provide all manpower, equipment, supplies, appurtenance, etc. to construct the RSA Security Fencing System along the south side of RWY7
